To better educate high-potential executives in the business of banking and to assist Utah bankers in their professional development goals, Pacific Coast Banking School (PCBS) partners with Utah Bankers Association (UBA) to offer a one-year tuition scholarship for the 2025 Resident Session of Pacific Coast Banking School (PCBS) in the amount of \$1,500.

#### THE PCBS PROGRAM

Since 1938, Pacific Coast Banking School, in partnership with the Foster School of Business at the University of Washington, has offered a premier three-year graduate-level leadership and financial management education program focused on the banking industry. The PCBS family includes over 20,000 bankers, with hundreds currently in key leadership roles in banks across the country. Premier instructors and cutting-edge curriculum offer practical answers to today's most critical banking dilemmas faced by bankers from all aspects of banking and all sizes of banks.

## **SCHOLARSHIP SESSION**

Students enroll in a three-year program, which includes a two-week resident session each August for three years held on the University of Washington campus in Seattle. The next session dates are August 17<sup>th</sup> – August 29<sup>th</sup>, 2025.

#### THE PROCESS

Tuition for the 2025 session is \$7,100, which includes a non-refundable registration fee of \$350, single room accommodations, classes, and most meals, along with administrative and faculty support for intersession work. The scholarship amount is **\$1,500** for the first year. The scholarship recipient is responsible for the balance of the tuition; in 2025 that amount is \$5,600.

The deadline for submitting scholarship applications to the Utah Bankers Association is **March 3, 2025.** The recipient of the scholarship will be selected by March 17, 2025.
